CLOPHILL, BEDS - SOLD approximately 0.9 acre with planning consent for 5 large detached houses.

ROTHWELL, NORTHANTS - ACQUIRED consented site for 91 dwellings at Harrington Road for Morris Homes.

WILSTEAD, BEDS - SOLD approximately 0.8 acre with planning consent for 4 detached houses to Bewick Homes.
